Characteristics of the Tokai region (Gifu • Aichi • Mie prefectures) 2

For the fields ("coordination style," e.g. automobile, auto parts, metal machine tools) where the Japanese manufacturing industry is highly competitive, more than 40% to 50% of these products are manufactured in the Tokai region.






